Whereas, Higher Education Department vide letter HE-Coll/COORD/APPTT/AP/2017 dated 18.10.2017 referred 10 posts [OM:05, RBA:02, SC:01, ST:01, ALC:01] of Assistant Professor in the discipline of Public Administration for selection of suitable candidates; and

Whereas, J&K Public Service Commission vide Notification No. 10-PSC (DR-P) of 2017 dated 27.10.2017 advertised the said posts for selection of suitable candidates; and

Whereas, Commission received 74 applications, which were scrutinized and 14 eligible candidates were called for interview; and

Whereas, the interview of the shortlisted candidates was conducted on 06.07.2021 with the assistance of experts; and

Whereas, one post each under RBA category and ALC category has left vacant due to non-availability of candidates.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

Note:-

1. The Commission reserves the right to have certificates/documents of the candidate verified, if at any later stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
2. In pursuance of Rule 51 of J&K PSC (Business & Procedure) Rule, 1980 and as reiterated by the Commission in the 20th extra ordinary meeting held on 20.06.2019, candidates having NET are entitled for points only from the higher qualification amongst M.Phil/Ph.D and where Ph.D itself is consumed

towards eligibility, the candidates are not entitled for any points for the same.

3. The select list is provisional and objection, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
