Subject: Select List for the posts of Lecturer Gynae & Obsts. (GMC-Jammu) in Health & Medical Education Department.

Notification No. 44 – PSC (DR-S) of 2021

Whereas, Health & Medical Education Department vide letter No. GM-159/2002-II dated 20.07.2006, ME/Leg/Gaz/26-25/2018-S dated 11.07.2018 and 12.09.2018 referred 01 post of Lecturer under ST category in the discipline of Gyne & Obsts (GMC-Jammu) for selection of suitable candidate; and

Whereas, J&K Public Service Commission vide Notification No. 13-PSC (DR-P) of 2018 dated 10.12.2018 advertised the said posts for selection of suitable candidate; and

Whereas, Commission received 01 application, which was scrutinized and accordingly was called for interview; and

Whereas, the interview of the shortlisted candidates was conducted on 02.08.2021 with the assistance of experts;

Whereas, one more candidate was called for interview on the basis of Court directions in writ petition titled Dr. Shafiq Bano Vs State and Others. The operative part of the petition is reproduced as under:-

Court Case LPA (SW) No.13/2018 & MP No. 01/2018 Dt: 07.05.2018 Titled Dr. Shafiq Bano V/S State & Ors.

“In view of the submission made by learned Government Advocate that the respondent shall extend the benefit of age relaxation to the appellant, we are inclined to modify the order passed by the learned Single Judge and direct the respondents to grant the benefit of relaxation in age to the appellant, then shall allow the appellant to participate in the selection process. Needless to state that the advertisement under challenge before the learned Single Judge, which pertains to ALC category, is also hereby quashed. Let the process of selection be initiated and concluded within a period of three months from today. To the aforesaid extent the order passed by the learned Single Judge is modified.

Accordingly, the appeal is disposed of along with connected MP”.

Whereas, Dr. Shafiq Bano remained absent and did not appear before the Interview Board.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, **Dr. Saima Sadiq D/O Sh. Mohd. Sadiq Shad R/O Guls Villa, Near HDFC Bank, By Pass Chowk, Nowgam** securing **56.15 points** is selected against the post of Lecturer Gynae & Obsts under ST Category in GMC Jammu.

1. The Commission reserves the right to have certificates/documents of the candidate verified, if at any later stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
2. The select list is provisional and objection, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
