Subject: Revised Select List for the posts of Lecturer Gynae & Obsts. (GMC-Jammu/Srinagar) in Health & Medical Education Department.

Whereas, Health & Medical Education Department vide letter No. ME/GAZ/187/2014 dated 25.04.2019 referred 01 post each under RBA category in GMC-Jammu GMC-Srinagar respectively of Lecturer in the discipline of Gynae & Obsts for selection of suitable candidates; **and**

Whereas, J&K Public Service Commission vide Notification No. 09-PSC (DR-P) of 2019 dated 08.07.2019 advertised the said posts for selection of suitable candidate; **and**

Whereas, Commission received 10 applications [Jammu:06, Srinagar:04], which were scrutinized and 08 eligible candidates [Jammu:05, Srinagar:03] were called for interview; **and**

Whereas, out of 8 eligible candidates, two candidates namely Ms. Lubna Rashid and Ms. Mahvish Qazi are common candidates as they have applied for GMC-Jammu as well as GMC-Srinagar; **and**

Whereas, the interview of the shortlisted candidates was conducted on 02.08.2021 with the assistance of experts; **and**

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the provisional select list was issued vide Notification No.41-PSC (DR-S) of 2021 dated 06.08.2021 in pursuance of Commission decision in its 17th meeting held on 06.08.2021 at Agenda Item No.17.3 with the stipulation that objection, if any, be submitted to the Commission within five days for examination and disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Whereas, in view of the above, Commission received a representation/declaration from Ms. Lubna Rashid (selected candidate) seeking withdrawal of her candidature/selection for the post of Lecturer Gynae & Obsts. in GMC-Jammu and with the request that she may be considered for selection for the said post in GMC-Baramulla notified vide Notification No.10-PSC (DR-P) of 2019; **and**

Whereas, simultaneously, the Commission also received a representation from Ms. Mahvish Qazi (selected candidate) with the request that instead of GMC-Doda she may be considered for appointment against the post of Lecturer Gynae & Obsts, GMC-Jammu being next in merit to Ms. Lubna Rashid.

Now, therefore, on the basis of above and approval of the Commission in its 18th meeting held on 07.09.2021 Agenda item No.18.3, the following revised provisional
