Whereas, , J&K Public Service Commission vide Notification No. 10-PSC (DR-P) of 2019 dated 08.07.2019 advertised the said posts for selection of suitable candidate; **and**

Whereas, Commission received 13 applications [GMC Anantnag: 04, GMC Baramulla: 03, GMC Doda: 02, GMC Kathua: 04], which were scrutinized and 11 eligible applicants [GMC Anantnag: 04, GMC Baramulla: 03, GMC Doda: 02, GMC Kathua: 02] were called for interview; **and**

Whereas, only five eligible candidates had submitted applications as per the breakup below:

Whereas, one shortlisted candidate namely Ms. Rehina Manzoor chose to remain absent on the date of interview; **and**

Whereas, the interview of the remaining four shortlisted candidates was conducted on 02.08.2021 with the assistance of experts; **and**

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, provisional select list was issued vide Notification No.42-PSC (DR-S) of 2021 dated 06.08.2021 in pursuance of Commission decision in its 17th meeting held on 06.08.2021 at Agenda Item No.17.3 with the stipulation that objection, if any, be submitted to the Commission within five days for examination and disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Whereas, the Commission received a representation/declaration from Ms. Lubna Rashid (selected candidate) who has been provisionally selected against the post of Lecturer Gynae & Obsts in GMC-Jammu seeking withdrawn of her candidature/selection for the post of Lecturer Gynae & Obsts. in GMC-Jammu and has further requested for considering her selection for the said post in GMC-Baramulla; **and**

Whereas, simultaneously, the Commission also received a representation from Ms. Mahvish Qazi (selected candidate) requesting for considering her appointment against the post of Lecturer Gynae & Obsts, GMC-Jammu being next in merit to Ms. Lubna Rashid.

Now, therefore, on the basis of above representations and approval of the Commission in its 18<sup>th</sup> meeting held on 07.09.2021 Agenda item No.18.4, the following revised provisional select list in respect of the Notification No.10-PSC (DR-P) of 2019 dated 08.07.2019 is hereby issued as under:-
