Short listing /Rejection Notice for the post of Assistant Professor, Tourism & Travel in Higher Education Department notified vide Notification No. 12-PSC (DR-P) of 2014 dated 29-05-2014 and Notification No.10-PSC

(DR) of 2017 dated 27.10.2017.

Whereas, the J&K Public Service Commission vide Notification No. 12-PSC (DR-P) of 2014 dated 29-05-2014 invited on line applications from the permanent residents of Jammu and Kashmir for 05 posts (OM=03, RBA=01, SC=01) of Assistant Professor, Tourism & Travel in Higher Education Department and in response the Commission received 39 application forms from the candidates.

Whereas, on scrutiny of application forms it was noted that there is no clarity on whether some of the candidates have acquired the prescribed qualification in the relevant subject; and

Whereas, the matter was taken up with the Higher Education Department for clarification and the Higher Education Department furnished the Minutes of the Equivalence Committee held on 10.9.2020. As per the decision of the Equivalence Committee, degree acquired in the in the subject of Tourism Management, Hospitality and Tourism, Tourism Administration, Tourism and Hospitality are equivalent with the qualification prescribed for the post viz Master's Degree in Tourism & Travel; and

Whereas, Rule 51 of J&K Public Service Commission (Business and Procedure) Rules, 1980, provides for the short listing of candidates for interview in the ratio of 1:5 and as such total 15 candidates under OM Category for 03 posts and, 05 candidate for 01 post under RBA category and, 05 candidates for 01 post under SC Category are required to be called for interview for the post of Assistant Professor Tourism & Travel advertised vide Notification No. 12-PSC (DR-P) of 2014 dated 29-05-2014. Due to less number of candidates available in the category of RBA and SC, the ratio of 1:5 could not be followed in respect of these two categories. The cut off merit under OM category is 58.53; and

Whereas, 10 more posts (OM=5, RBA=2, SC-1, ST-1, ALC-1) of Assistant Professor, Tourism & Travel were referred by the Higher Education

Department and the said posts have been advertised vide Notification No. 10-PSC (DR)of 2017 dated 27.10.2017.

Whereas, in terms of amendment in Rule 51 of J&K PSC (Business & Procedure) Rule, 1980, notified vide Notification No. PSC/EX/11/37 dated 20-03-2011, short listing of candidates for interview has been done in the ratio of 1:3 and as such total 15 candidates under OM Category for 05 posts, 06 candidate for 02 post under RBA category, 03 candidates for 01 post under SC Category, 03 candidates for 01 post under ST category and 03 candidates for 01 post under ALC category are required to be short listed and called for interview for the post of Assistant Professor Tourism & Travel advertised vide Notification No. 10-PSC (DR) of 2017 dated 27.10.2017. The cut off merit under OM category is 25.16, for RBA category 22.17, SC category = 22.91, ST category = 22.98. The ration of 1:3 ratio could not be followed in respect of ALC category as only 01 candidate has applied for the post.
