Whereas, the J&K Public Service Commission vide Notification No.06-PSC(DR-P) of 2018 dated 13.3.2018, item No. 228, invited on line application forms from the permanent residents of Jammu and Kashmir for the 02 posts(OM 01 & RBA 01) of Assistant Professor (**Structural Engineering**) in the Higher Education Department. In response to our advertisement notification 42 candidates were applied for the post. The Prescribed qualification for the posts are as under:

"B.E/B. Tech in Civil Engineering and Master's Degree in Structural Engineering with minimum 60% marks at either level and one year of relevant professional experience.

Whereas, the deficiency/rejection was notified vide notice dated 10.1.2019 in which candidates were advised to submit the deficient documents within 10 days from the issuance of notice.

Whereas, the case has been again processed before the Commission and it has been decided that as per the nomenclature of the posts, the teaching experience can be considered to determine the eligibility for the post.

Whereas, in response to the above notice the commission has received deficient documents from some of the candidates and which were again scrutinized for determining the eligibility as per the provisions of Rule 51 of J&K Public Service Commission(Business and Procedure) Rules, 1980 as amended from time to time, which provides for weight age to be given to the Academic Performance, outreach and extra-curricular activities, special attributes and teaching skills constituting 57 points(On pro-rata basis-i-iv) with the break up tabulated as under:-

Whereas, under RBA category there is only one candidate are provisionally found eligible for interview/viva voce; and

Whereas, after compilation of the data with respect to the above weightage points and the ratio to be adopted for short-listing of candidates for interview, the cut of merit under OM Category is **28.14**.
