Subject: Short listing/Rejection of the candidature of candidates for the post of **Assistant Professor, Television & Film Making** in Higher Education Department notified vide Notification No.10-PSC (DR-P) of 2017 dated 27.10.2017.

Whereas, the J&K Public Service Commission vide Notification No.10-PSC (DR-P) of 2017 dated 27.10.2017 invited on line applications from the permanent residents of Jammu and Kashmir for 12 posts (OM= 06, RBA =03, SC= 01 and ST 01 and ALC 01) of Assistant Professor Television & Film Making in the Higher Education Department and in response the Commission received 46 application forms from the candidates; and

Whereas, on scrutiny of application forms it was noted that there is no clarity whether some of the candidates have acquired the prescribed qualification in the relevant subject; and

Whereas, the matter was taken up with the Higher Education Department for clarification and the Higher Education Department furnished the Minutes of the Equivalence Committee held on 10.9.2020. As per the decision of the Equivalence Committee, degree acquired in "Mass Communication, Mass communication and Journalism, Communication, Convergent Journalism, Theatre Arts, Theatre & Television" are equivalent with the qualification prescribed for the post viz Master's Degree in Television & Film Making .

Whereas, Rule 51 of J&K Public Service Commission (Business and Procedure) Rules, 1980, provides for the short listing of candidates for interview in the ratio of 1:3 and as such total **18 candidates** under OM Category for **06 posts**, **09 candidate** for **03 post** under RBA category, **03 candidates** for **01 post** under SC Category, **03 candidates** for **01 post** under ST category and **03 candidates** for **01 post** under ALC category are required to be called for interview. Due to less number of candidates available in the category of RBA, SC and ST, the ratio of 1:3 could not be followed in respect of these three categories. Besides, no candidate under ALC category has applied for the said post. The cut off merit under OM category is 24.84

The breakup of weight-age to be given to the Academic performance, outreach and extra-curricular activities, special attributes and teaching skills constituting 57 points, (on pro-rata basis i-iv only) as provided in rule 51 of J&K PSC (Business & Procedure) Rules 1980 with the break-up tabulated as under:-
