Subject: Representation against the select list for the posts of Lecturer Anesthesiology (GMC-Srinagar) in Health & Medical Education Department - consideration thereof.

Notice

Whereas, Health & Medical Education Department vide letter No. ME/GAZ/187/2014 dated 25.04.2019 referred 04 posts [OM:02, RBA:01 & SC:01] of Lecturer in the discipline of Anesthesiology (GMC-Srinagar) for selection of suitable candidates; **and**

Whereas, , J&K Public Service Commission vide Notification No. 08-PSC (DR-P) of 2019 dated 20.05.2019 advertised the above said posts for selection of suitable candidates; **and**

Whereas, the Commission received 49 applications, which were scrutinized and 42 eligible candidates were called for interview; **and**

Whereas, the interview of the shortlisted candidates was conducted on 29.07.2021 & 30.07.2021 with the assistance of Experts; **and**

Whereas, provisional select list was issued vide Notification No.35-PSC (DR-S) of 2021 dated 06.08.2021 in pursuance of Commission decision in its 17th meeting held on 06.08.2021 at Agenda Item No.17.2, with the stipulation that objection, if any, may be submitted to the Commission within five days for examination and disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Whereas, in response to the above notification, one Sh. Tantry Tariq Gani S/O Sh. Ab Gani Tantry represented in the Commission pleading that his marks in Academics in the above referred select list have been shown as 30.88 points whereas his actual Academic marks should have been shown as 34.05 points; **and**

Whereas, the representation of Sh. Tantry Tariq Gani S/O Sh. Ab Gani Tantry was considered in the Commission and after carefully scrutiny of the entire record pertaining to Academics, it has come to fore that due to inadvertent error the Academic marks have been shown as 30.88 points in the award sheet instead of actual 34.05 points; **and**

Whereas, on the basis of the above, the grievance of the candidate has been found correct/genuine and accordingly the Commission disposed of the representation of the candidate vide Notice dated 17.09.2021; **and**

Whereas, in response to the above notice, Dr. Shahzada Gani submitted a representation on 21.09.2021 alleging that one Dr. Tantry Tariq Gani S/O Ab. Gani Tantry was pursuing Super Specialty course as a DM candidate while advertisement was called for filling of said posts, as such cannot be granted dual benefit i.e. points for experience as well as higher qualification, in terms of rules of J&K PSC (Business & Procedure) Rules; **and**

Whereas, the representation of Dr. Shahzada Gani has been examined with reference to the records of Mr. Tantry Tariq Gani and it has been found that Mr. Tantry Tariq Gani has not been awarded any points for higher qualification i.e. DM, however, his DM has been treated as teaching experience w.e.f. 14.09.2017 to 25.10.2019, as provided in Rule 51 of J&K PSC (Business & Procedure) Rules, 1980, as amended from time to time.

Now, therefore, the representation of Dr. Shazada Gani having being considered and found devoid of any merit, is hereby rejected.
