Whereas, the Higher Education Department vide indent no. HE-Coll/Uni-117/AC/16 dated 01.01.2018, referred two posts (OM= 01 & RBA= 01) of Professor/HOD, Architecture in School of Architecture for selection of the suitable candidates; **and**

Whereas, the J&K Public Service Commission vide Notification No.06-PSC(DR-P) of 2018 dated 13.3.2018, under item No. 226, invited online application forms from the permanent residents of Jammu and Kashmir for the said posts of Professor/HOD, Architecture in School of Architecture in the Higher Education Department. In response to the said notification, 03 applications were received. The Prescribed qualification for the posts is as under:

"Bachelor's Degree in Architecture and Master's Degree in Architecture with minimum 60% marks at either level and fourteen years (14) experience in teaching/research/Professional work out of which a full-time teaching experience of minimum five years OR

Nineteen years of professional experience.

Desirable Ph.D in Architecture.

Whereas, after scrutiny of documents, the deficiency/rejection notice was issued vide notice dated 02.1.2019, in which candidature of two candidates namely Mr. Vikas Bholra and Ms. Arshi Khajuria was rejected; **and**

Whereas, the remaining one candidate namely Mr. Navin Gupta was advised to submit the deficient documents, if any, in order to ascertain his eligibility for the post within a week from the issuance of the notice dated 02.1.2019; **and**

Whereas, Mr. Navin Gupta submitted the deficient documents; **and**

Whereas, the deficient documents submitted by the Mr. Navin Gupta have been scrutinized and it has been found that the said candidate does not possess the requisite experience and is as such not eligible for the post.

Now, therefore, in view of the aforementioned facts, the candidature of Mr. Navin Gupta (Registration No. 18010622600004) who had applied under Notification No.06-PSC (DR-P) of 2018 dated 13.3.2018, under item No. 226, for the post of

Professor/HOD, Architecture in the School of Architecture in the Higher Education Department, is hereby rejected.
