In pursuance of the provisions contained in Government Order No. 299 of 1976 dated 04.12.1976, read with J&K Public Service Commission Public Service Commission (Conduct of Examination) Rules, 2005, the candidates enlisted in the Annexure - I & II who, among others, appeared in the Assistant Director Statistical-Cum-Evaluation Competitive Examination (Jammu and Kashmir Economic & Statistical Service)-2013 are directed to report before the respective standing Medical Boards at Government Medical College Jammu/Srinagar for Medical Examination.

In terms of the note under regulation 9 of Government Order No. 299 of 1976 dated 04.12.1976, instructions to appear before the Medical Board should not be deemed to mean that the candidates, if found fit, are necessarily given an appointment.

No individual call letter shall be sent to the candidates, the candidates should presume the publication as call letter and report to the Principal Medical College concerned. The candidate will have to pay a fee as prescribed by the respective Medical Board before check-up.

Any candidate desirous of appearing before a standing Medical Board other than his/her division on valid grounds, to be considered by the Commission, should immediately contact the Commission Secretariat, so that the requisite documents/intimation is sent to the concerned Medical Board.

**Note II:** The lists in Annexure I & II are subject to the outcome of writ petition pending before any competent court of jurisdiction.
