**Subject: Recommendation of Selection for the posts of Assistant Engineer (Civil) in Public Works (R&B) and PHE/I&FC Departments - modification thereof.**

**Notification No. 10-PSC (DR-S) of 2017**  
**DATED: 27/03/2017**

Whereas, result for the posts of Assistant Engineer (Civil) in the Departments of PHE/FC/Irrigation and PWD was declared vide Notification No.09-PSC of 2017 dated 14.3.2017;

whereas, the Commission received following three representations pertaining to the Select Lists published under different notifications with the pleas briefly detailed as under:-

- i. *Mr. Subzar Ahmad has represented that he being Physically Handicapped has not been given the reservation benefit under PHC category provided under Reservation Rules despite having qualified the prescribed bench-mark.*
- ii. *Mr. Agazahid Rahman Raina represented that his percentage has been wrongly calculated as 61.9% by applying incorrect formula. His contention is that as per conversion formula adopted by the concerned Institute his percentage would be 66.9%. He has produced relevant documents to substantiate his claim.*
- iii. *Ms Shazia Nabi has requested that she has not been selected under SLC category despite having higher merit i.e. 58.04 points than the selected candidate namely Mudasir Farooq Tali who has secured only 57.30 points under Notification No.01-PSC of 2015 dated 5.1.2015.*

whereas, the representations were thoroughly examined and the Commission arrived at following conclusions:-

- i. *The representation of Mr. Subzar Ahmad was found based on facts and it has been observed that he has inadvertently not been considered under PHC category despite having secured 45.18 points under Notification No.18-PSC of 2013 dated 15.10.2013 whereunder 3 posts were allotted to this sub-category by applying 3% horizontal reservation. He is to be included in the select list at the bottom of Open Merit category. By including his candidature the last selected candidate namely Vijay Kumar who belongs to SC category will be dislodged and shall figure at Sr.No.01 of SC category under Notification No.18-PSC of 2013. The last selected candidate under SC category namely Avdesh Badgal at Sr. No.07 shall now figure at Sr. No. 01 of the wait list instead of Nupper Sanyal B.D.No.399 who is required to be excluded from the wait list.*

- ii. Merit position of Mr. Agazaid Rahman Raina, B.D.No.155 has wrongly been awarded 27.85 points instead of 30.10 points by applying wrong formula. The candidate has acquired his B. Tech degree from NIT Srinagar in 2007. He has obtained Cumulative Grade Point Average (CGPA) of 6.69 on a scale of 10. The following formula has been adopted by the concerned Institution for conversion of CGPA into percentage:-

$$\text{Percentage(\%)} = (\text{CGPA} \times 10)$$

By applying the above formula his percentage would be 66.9% which comes to 30.10 points on account of weightage to Basic Qualification. However, in his case wrong formula has been adopted i.e percentage=(CGPAx10)-5. After rectification of this error, his overall revised merit would be 56.60 and he will figure at Sr. No.10 under RBA category in Notification No.18-PSC of 2013 dated 15.10.2013. By his inclusion in the select list, last selected candidate namely Ovais Ndeem Bhat B.D No.153 will be excluded and shall figure at Sr.No.2 of the select list under RBA category in Notification No.01-PSC of 2015 dated 5.1.2015 by virtue of his merit and preference. The last selected candidate namely Mehtab Ahmad Malik under RBA category in Notification No.01-PSC of 2015 shall be excluded from the select list but will figure in the wait list of both the Notifications i.e 18-PSC of 2013 and 1-PSC of 2015 respectively.

- iii. Ms Shazia Nabi has been shortlisted and interviewed under SLC category at B.D.No.396 for the posts notified under Notification No.18-PSC of 2013 and 01-PSC of 2015, the candidate has secured total weightage of 57.04 and 58.04 points against Notification No.18-PSC of 2013 and 01-PSC of 2015 respectively. She has not qualified under Notification No.18-PSC of 2013 by virtue of her merit. However, she has qualified under Notification No.01-PSC of 2015 under which 01 post is reserved for SLC category. The candidate namely Mudasir Farooq Talie B.D No.390 who has been declared as selected candidate with total weightage of 57.30 points need to be excluded and shall be replaced by Ms Shazia who has secured 58.04 points under Notification No.01-PSC of 2015. However, by virtue of merit-cum-preference, Mr. Mudasir shall figure at Sr.No.18 under OM category of Notification No.11-PSC of 2013 dated 28.06.2013. With his inclusion the last selected candidate namely Younis Majid BD No158 who belongs to RBA category will be dislodged and shall figure at Sr.No.1 of the select list under RBA category in Notification No. 11-PSC of 2013 dated 28.06.2013. With the inclusion of Mr. Younis Majid, the last selected candidate under RBA category namely Amjid Ali Manhas BDN0.210 figuring at Sr. No.08 shall be excluded from the Select List and shall now figure at Sr. No. 01 of the wait list instead of Mohammed Ayaz Bhat BDN0. 215 who is required to be excluded from the wait list.

1. Mr Subzar Ahmad Wani S/o Mohd Maqbool Wani R/o Wanipora, Hergam Sajam, Kokernag whose merit has already been declared as 45.18 is included in the Select List and shall figure at Sr. No.43 under OM/PHC category of Notification No.18-PSC of 2013 dated 15.10.2013;
2. Mr. Vijay Kumar S/o Roshan Lal C/o Bhat General Store, Shantiporam, Lower Roop Nagar Muthi, Jammu (SC/OM) with merit position of 60.49 is excluded in the Open Merit category and included in the SC category at Sr. No.1 of Notification No.18-PSC of 2013 dated 15.10.2013;
3. Merit position of Mr. Agazaid Rahman Raina S/o Abdul Rahman Raina R/o Inshan (Warwan) Tehsil Marwah District Kishtwar is revised as 56.60. He is included at Sr. No.10 of the select list of RBA category under Notification No.18-PSC of 2013 dated 15.10.2013;

Mr. Ovais Nadeem Bhat S/o Bashir Ahmad Bhat R/o Gundi Maqsood, Tehsil Chadura, District Budgam who is presently figuring at Sr. No. 15 under RBA category of Notification No.18-PSC of 2013 dated 15.10.2013 is excluded and shall now figure at Sr. No.2 of the select list of RBA category under Notification No.01-PSC of 2015 dated 5.1.2015;

5. Mr. Mehtab Ahmad Malik S/o Mohd. Sadiq Malik R/o Jawahar Nagar, Near Grid Stationa 132-33-KU P.O. Jawahar Nagar figuring at Sr.No. 07 of the select list under RBA category is excluded from the select list of RBA category under Notification No.01-PSC of 2015 dated 2.1.2015 and shall figure at Sr.No.01 of the wait list of Notification No.18-PSC of 2013 dated 15.10.2013 and 01-PSC of 2015 dated 5.1.2015;
6. Ms Shazia Nabi D/o Gh. Nabi Dobi R/o Bagh-E-Islam Krankshivon Colony Sopore District Baramulla with aggregate merit position of 58.04 points is included in the Select list of SLC category against Notification No. 01-PSC of 2015 dated 5.1.2015 in place of Mudasir Farooq Talie S/o Farooq Ahmad Talie R/o Sheerbugh Sultanpora, Pattan, Baramulla;
7. Mr. Mudasir Farooq Talie S/o Farooq Ahmad Talie R/o Sheerbugh Sultanpora, Pattan, Baramulla with aggregate merit position of 57.30 points is excluded from the Select List of SLC category against Notification No. 01-PSC of 2015 dated 5.1.2015, having aggregate merit of 56.80 points shall figure at Sr.No. 18 under OM category against Notification No.11-PSC of 2013 dated 28.6.2013;
8. Mr. Younis Majid S/o Ab Majid Bhat R/o Hushroo Tehsil Chadura District Budgam PO Chadura with total points of 54.46 who belongs to RBA Category is excluded from the Select List of OM category shall now figure at Sr.No.1 under RBA Category against Notification No.11-PSC of 2013 dated 28.6.2013.
9. Mr. Amjid Ali Manhas S/o Munir Hussain Khan C/o Iqra Book Centre Near Bus Stand, Mendhar District Poonch with aggregate merit position of 46.04 points is excluded from the select list under RBA Category and shall now figure at Sr.No. 1 of the wait list against Notification No. 11-PSC of 2013 dated 28.6.2013.
