Whereas, the Higher Education Department referred 22 posts (OM: 10, RBA: 05, SC: 03, ST: 02, ALC: 02) of Assistant Professor in the discipline of Hindi to the Public Service Commission for being filled up from amongst the suitable candidates; and

whereas, the Hon'ble High Court in SWP No.3135/2015, MP No. 01/2015 titled Suresh Kumari Vs State & Ors titled passed an interim direction, restraining the Commission from finalizing the selection process for the said posts after interview/viva-voce; and

whereas, the Hon'ble Division Bench in LPA (SWP) No. 180/2016 titled J&K PSC Vs Suresh Kumari & Ors filed by the Commission while disposing off the appeal on 28.12.2016 has been pleased to dismiss the writ petition filed by the petitioner and the interim directions also stand vacated.

Now, therefore, on the basis of performance in the interview coupled with the weight-age in respect of academic merit, experience and other related parameters, the **Merit** of the candidates who appeared in the interview, is enclosed as "**Annexure-A**" to this Notification.

Consequent upon the above, the **Select List** of the candidate against the available post is given in "**Annexure-B**" to this Notice.

#### <u>Note:-</u>

1. The Commission reserves the right to have certificate/documents of the candidate verified, if it is at any stage found expedient to do so. The Select

List is provisional and is subject to the outcome of writ petitions pending before any competent Court of law.

- 2. 01 post in ALC Category remained unfilled as the candidate did not cross the bench of 40 points for selection. One more post in ALC category remained vacant due to non-availability of eligible candidate.
