Whereas, the Higher Education Department vide communication No. Edu/Coll/apptt/AP/2014 dated 19.5.2014 referred 05 posts (OM: 02, RBA, 02 and ST : 01 of Assistant Professors in the discipline of Punjabi to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates in terms of SRO-124 dated 21.4.2014; and

whereas, the J&K Public Service Commission vide Notification No. 12-PSC (DR-P) of 2014 dated 29.5.2014 invited applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification. In the said notification it was inter alia mentioned at Note-2 that the candidates who have already applied in response to Notification No. 09-PSC (DR-P) of 2013 dated 23.5.2013 for the above mentioned post(s) need not apply subject to the fulfillment of eligibility requirement as laid down in SRO -124 dated 21.4.2014; and

whereas, in response to the above said Notification, the Commission received 14 applications in OM category. No candidates applied under RBA and ST category; and

whereas, after scrutiny of the documents, certain deficiencies have been noticed and accordingly a deficiency notice stands issued vide PSC Notice dated 12.12.2015; and

whereas, short-listing of the candidates is to be done in terms of Rule 40-2(b) of J&K Public Service Commission (Business and Procedure) Rules, 1980 on the basis of percentage of marks obtained in the basic prescribed qualification and weight age to be given to higher qualification; and
