Sub: Interview/Deficiency notice for the post of Assistant Architect in Housing & Urban Development Department.

Whereas, the Housing & Urban Development Department vide communication No. HUD/Arch/16/2015 dated 27.08.2015 had referred 02 (Two) (Open 01 & RBA 01) posts of Assistant Architect in Housing & Urban Development Department to the J&K Public Service Commission; and

whereas, the J&K Public Service Commission, vide Notification No. 11-PSC(DR-P) of 2015 dated 05.10.2015 invited applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification; and

whereas, in response to the above said Notifications, the Commission received 73 applications

whereas, as per J&K PSC (Business & Procedure) Rule 1980 amended from time to time, the candidates to be called for interview are required to be shortlisted on the basis of percentage of marks secured in the qualifying examination and weight-age to be given to the higher qualification. Accordingly, under Open category against one post five candidates who are falling within the short-listing criteria have been shortlisted on the basis of their percentage of marks and higher qualification. Against one post under RBA category only three candidates have applied; and

whereas, the criteria adopted for calculation of merit of the candidates only under Open category has been worked out as per the table given below:-

The cutoff merit under Open Merit category has been worked out as 73.08 and under RBA Category no short-listing has been done as less number of candidates have applied under said category.

However, the candidates who have applied for the said post and do not fall in the shortlist criteria may represent to the Commission with sufficient proof of having equal or higher merit than the candidates shortlisted within six days from the date of issuance of notice.

The interview of following short-listed candidates shall be held on 31.03.2016 subject to further verification of all the original documents/ testimonials at the time of interview. The candidature of all the short-listed candidates is purely provisional and are advised to submit their deficient documents within six days otherwise they shall not be allowed to appear in the interview.
