It is notified for information of the general public that in the Notification No.07-PSC (DR) of 2017 dated 07.06.2017 after the table under the header "For the post of Assistant Professor and its equivalent in Higher Education Department" and before para under heading "Shortlisting for Interview" the following shall be added in the existing Rule 51 of the Jammu & Kashmir Public Service Commission (Business & Procedure) Rules, 1980.

The assessment at a selection for the posts of Librarian and Physical Training Instructor in Higher Education Department, which is solely by means of an interview shall be based on a scale of 100 weightage points with break-up thereof as under:

1. Academic Performance (Prorata basis)

(c) M.Phil	=	03
(d) Ph.D	=	06
(e) Any additional degree/ PG Diploma in the field of Lib. Science	=	<u>02</u>

2. Publications in the relevant field:-

- (i) Research papers published in referred journals as notified by the UGC. 0.25 marks per publication to the maximum of 4 marks (as first, second or third author only) = 04
- (ii) Book/s published by National/International publishers with mark per book by single ISBN/ISSN number (01 author to the maximum of 02) =02
- (iii) Chapter in book published by National/International publishers with ISBN/ISSN Number (0.5 per chapter to the maximum of 02) = 02

B-PHYSICAL TRAINING INSTRUCTORS (DIRECTOR)

Physical Fitness Test and norms

- a) Subject to the provisions of these Regulations, all candidates who are required to undertake the physical fitness test shall be required to produce a medical certificate certifying that he/she is medically fit before undertaking such tests.
- b) On production of such certificate mentioned in sub-clause (a) above, the candidate would be required to undertake the physical fitness test in accordance with the following norms:
