Whereas, the J&K Public Service Commission, vide Notification No. 12-PSC(DR-P) of 2014 dated 29.05.2014, invited applications on the prescribed format from the permanent residents of Jammu and Kashmir possessing the prescribed Education qualification. In the said notification, it was, inter-alia, mentioned at Note-2 that the candidates who have already applied in response to Notification No. 09-PSC (DR-P) of 2013 dated 23.05.2013, for the above mentioned post (s) need not to apply subject to the fulfillment of eligibility requirement as laid down in SRO-124 dated 21.04.2014; and

Whereas, in pursuance of the Commission's decision taken in its extra ordinary meeting held on 06.01.2016, all such candidates who have been declared to have qualified their SET/NET by virtue of revised notifications were informed through the medium of the notice dated 07.01.2016 to submit their applications alongwith the documentary proof of having qualified SET/NET in 2013 together with other documents to participate in interview process in their respective subjects as and when the interview schedule in their cases is notified provided they were otherwise eligible on the cutoff date i.e 02.07.2014; and

Whereas, in pursuance of the Notice dated 07.01.2016, among other candidates, the following candidates also submitted their representations alongwith other documents for the posts of Assistant Professor in the disciplines of Urdu in Higher Education Department:-

Whereas, Mr. Basharat Hussain Bhat S/o Abdul Gani Bhat R/o Chandpora Kanalwan, Anantnag filed a writ petition No. 1010/2017, titled Basharat Hussain Bhat V/s State & Ors before the Hon'ble High Court at Srinagar, which was decided by the Hon'ble High Court vide Judgement dated 15.01.2017.

Whereas, in pursuance of the said judgement of the Hon'ble High Court, the Commission in its 13<sup>th</sup> extra ordinary meeting held on 21.08.2017 decided to

implement the Judgment of the Hon'ble High Court, in SWP No: 1010/2017 titled Basharat Hussain Bhat V/s State & Ors in respect of all similar situated cases; and

Whereas, accordingly, the Commission examined all such cases and found the cases detailed below to be considered at par with the case of Sh. Basharat Hussain Bhat referred above; and

Whereas, the Commission in its 9<sup>th</sup> meeting dated 12.12.2017 has approved declaration of result of similar situated cases in the discipline of Education, Botany, Geography, Commerce, History and Chemistry; and Urdu; and

Now, therefore, on the basis of performance of the aforesaid candidates, in the interview coupled with the weightage in respect of academic merit, experience and other related parameters for the post of Assistant Professor, Urdu, the merit position of such candidates is as under:-
