Whereas, merit of the last candidate under Open Merit has been notified as 54.75; and

Whereas, one Ms. Shahina Islam placed at S.No.24 of General Bio Data under Open merit has scored 52.56 and does not fall in the selection criteria; and

Whereas, as a result of examination of representation sent by Ms. Shahina Islam D/O Late Ghulam Nabi Malik R/O Nadigam, Shopian, it has surfaced that she has not been awarded 3 points erroneously on account of her experience in the grade pay of 4200/- as Documentalist in Government Medical College, Srinagar; and

Whereas, the 3 points accruable to her on the basis of criteria laid down by the Commission are incorporated in her merit thus raising her merit from 52.56 to 55.56; and

Whereas, by adding these points, she will be placed in between S.No.23 (55.62) and 24 (55.23) of the select list under Open Merit.

Now, therefore, in view of above the name of Ms. Shahina Islam shall and shall always be deemed to have been added in the select list under Open Merit at S.No.23A of the Annexure 'B' of Notification No.16-PSC (DR-S) of 2018 dated 06.04.2018.
