Subject: Short-listing/deficiency/rejection of the candidates for the post of Assistant Professor, Sericulture in Higher Education Department-submission of deficient documents thereof.

Whereas, the Higher Education Department vide communication No. Edu/Coll/apptt./A.P/2014 dated 19.05.2014, had referred 03 (OM=01, RBA=01, SC=01,) posts of Assistant Professors in the discipline of Sericulture to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates in terms of SRO-124 dated 21.04.2014; and

whereas, the J&K Public Service Commission, vide Notification No. 12-PSC(DR-P) of 2014 dated 29.5.2014 invited applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification. In the said notification it was inter alia mentioned at Note-2 that the candidates who have already applied in response to Notification No. 09-PSC(DR-P) of 2013 dated 23.05.2013 for the above mentioned post(s) need not apply subject to the fulfillment of eligibility requirement as laid down in SRO-124 dated 21.04.2014; and

whereas, in response to the above said Notifications, the Commission received 21 applications; and

whereas, after security of the documents, the short-listing of the candidates is to be done in terms of Rule 40-II (b) of J&K Public Service (Business & Procedure) Rules 1980 on the basis of percentage of marks obtained in the basic prescribed qualification and weightage to be given to higher qualification; and

whereas these applications were scrutinized; and

Now, therefore, the following candidates have been shortlisted on the basis of marks obtained in basic qualification and weightage given to higher qualification subject to making good the deficiency indicated against each candidate therein:-


