Subject: Shortlisting/deficiency /rejection notice of the candidates for the post of Assistant Professor (Statistics) in Higher Education Department-submission of deficient documents thereof.

Whereas, the Higher Education Department vide communication No. Edu/Coll/apptt./A.P/23014 dated 19.05.2014 had referred 11 number of posts of (OM- 06, RBA-02 SC-01, ST-01 & ALC -01) of Assistant Professors in the discipline of Statistics to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates in terms of SRO -124 dated 21.04.2014; and

whereas, the J&K Public Service Commission, vide Notification No. 12-PSC(DR-P) of 2014 dated 29.05.2014 invited applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification. In the said Notification it was inter-alia mentioned at Note para-2 that the candidates who have already applied in response to Notification No. 09-PSC(DR-P) of 2013 dated 23.05.2013 for the above mentioned posts need not apply subject to the fulfilment of the eligibility requirements as laid down in SRO-124 dated 21.04.2014; and

whereas, in response to the above said Notifications, the Commission received 28 applications; and

whereas, the short-listing of the candidates is to done in term of Rules 40-II(b) of J&K Public Service commission (Business and procedure) Rules 1980 on the basis of percentage of marks obtained in the basic prescribed qualification and weight age to higher qualification; and

Whereas, 25 candidates under OM category, 10 candidates each under RBA and SC Category and 05 candidates under ALC category are to be shortlisted in pursuance to Rule 40-II(b) of J&K Public Service commission (Business and Procedure) Rules 1980 on the basis marks obtained in basic qualification and weight age given to higher qualification ; and

Whereas no short listing is required as the number of candidates who have applied in each category for the post are less than the candidates

required to be shortlisted or found ineligible. Besides, no candidate had applied under ALC category.

Candidates who have obtained court orders from the Hon'ble High Court in the above mentioned disciplines for appearing in the interview may also represent before the Commission alongwith Court orders within fifteen days for appearing in the interview at their own risk and responsibility and subject to final outcome of the writ petition.
