Whereas, the Higher Education Department vide communication No.Edu/Coll/Apptt./A.P/2014 dated 19.05.2014,inter-alia, had referred 06 (six) posts of Assistant Professor in the discipline of Functional English to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates in terms of SRO-124 dated 21.04.2014; and

whereas, the J&K Public Service Commission, vide Notification No. 12-PSC (DR-P) OF 2014 dated 02.07.2014, invited applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification in the said notification it was inter alia mentioned at Note 2 **that the candidates who have already applied in response to Notification No.09-PSC (DR-P) of 2013 dated 23.05.2013 for the above mentioned post (s) need not apply again subject to the fulfillment of eligibility requirement as laid down in SRO-124 dated 21.04.2014, and**
