Subject: Short listing / Interview of the candidates for the post of Assistant Professor, Social Work in Higher Education Department notified vide Notification 10-PSC (DR-P) OF 2017 Dated: 27.10.2017.

Whereas, the J&K Public Service Commission, vide Notification **No.10-PSC (DR-P) of 2017 dated 27.10.2017**, invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification for the post of Assistant Professor **Social Work** in Higher Education Department against **05 posts of OM, 02 posts of RBA, 01 post of SC, 01 post of ST and 01 post of ALC category** were advertised and in response to the above said Notification, the Commission received 97 applications form in the said discipline; and

Whereas, the verification/ scrutiny of the documents was conducted by the Screening Committee constituted for the purpose and the documents of some candidates were found deficient and accordingly the deficiency notice was issued vide Notice dated 16.01.2019; and

Whereas, the deficient documents were received from the candidates in response to notice dated 16.01.2019 and the said documents were again verified/scrutinized by the Screening Committee for short listing of the candidates; and

Whereas, the short listing of the candidates was conducted as per provisions of **Rule 51 of J&K Public Service Commission (Business and Procedure) Rules, 1980** as amended from time to time, which provides for weightage to be given to the Academic performance, outreach and extra-curricular activities, special attributes and teaching skills constituting total **57 points, (on pro-rata basis)** with the break-up tabulated as under:

Whereas, the rule 51 of J&K Public Service Commission (Business and Procedure) Rules, 1980 as amended from time to time, further provides for the short listing of the eligible candidates to be called for interview in the ratio of 1:3 and as such total 15 candidates are to be shortlisted under OM Category for 05 advertised posts, 06 candidates under RBA Category for 02 advertised posts, 03 candidates under SC Category for 01 advertised post, 03 candidates under ST Category for 01 advertised post and 03 candidates under ALC Category for 01 advertised post respectively are to be shortlisted on the basis of the Academic Performance, Outreach and extra-curricular activities, Special attributes and Teaching skills as per the weightage detailed above; and

Whereas, after compilation of the data with respect to the above weightage points and the ratio to be adopted for short listing of candidates for interview, the cut of merit under OM category is 26.57 in respect of Assistant Professor, **Social Work** and the cut of merit for ST is 26.65. In case of RBA and SC category the shortlisting of the candidates was not required as lesser number of candidates as required for shortlisting as per Rules had applied for the posts. However no application forms have been received against ALC category.


