Whereas, the Health & Medical Education Department, vide letter No, ME-Gztd-525/2023-01 (CC: 7331789), dated 09.07.2024, referred three (03) posts (OM – Category-02, SC Category-01) of Assistant Professor, General Medicine, SKIMS, to the J&K Public Service Commission, for selection of suitable candidates.; and,

Whereas, the said posts were advertised vide Notification No. 03-PSC (DR-P) of 2025 dated 04.02.2025. The cut-off date for determination of eligibility was fixed as 05.03.2025; and,

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 44,ii(a) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 07.10.2025; and,

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2025/53 Dated: 12.11.2025. Ten (10) candidates were declared to have qualified for interview provisionally; and,

Whereas, the viva-voce of candidates was conducted on 16.03.2026, with the assistance of Experts from outside of UT.


