3. Only such candidates shall be allowed to appear before the interview Board who fulfilled their deficiencies alongwith MSP certificates in accordance with the UGC Regulations, 2009 and Regulations, 2016 whichever is applicable before the interview date.
4. The candidates shall produce their original certificates/testimonials on the date of interview.
5. Candidates who have obtained Court orders from the Hon'ble High Court in the above mentioned disciplines for appearing in the interview may also represent before the Commission alongwith Court orders by or before 12th of July, 2016 for appearing in the interview at their own risk and responsibility.
