Whereas, the Higher Education Department vide communication No.HE/Coll/Apptt/A.P./2017 dated 18.10.2017, among others referred **49 posts (OM=29, RBA=09, ST= 05, SC=04, SLC=01, ALC =01)** of Assistant Professor, **Dogri** in Higher Education Department to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates; and

Whereas, the J&K Public Service Commission, vide Notification **No.10-PSC (DR-P) of 2017 dated 27.10.2017** invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification for the post of Assistant Professor **Dogri** in Higher Education Department and in response to the above said Notification, the Commission received **109 application** forms in the said discipline; and

Whereas, the verification/ scrutiny of the documents was conducted by the Screening Committee constituted for the purpose and the documents of some candidates were found deficient and accordingly the deficiency notice was issued vide Notice dated 30.01.2019; and

Whereas, the deficient documents were received from the candidates in response to notice dated 30.01.2019 and the said documents were again verified/scrutinized by the Screening Committee for short listing of the candidates; and

Whereas, the short listing of the candidates was conducted as per provisions of **Rule 51 of J&K Public Service Commission (Business and Procedure ) Rules , 1980** as amended from time to time, which provides for weightage to be given to the Academic

performance, outreach and extra –curricular activities, special attributes and teaching skills constituting total **57 points, (on pro-rata basis)** with the break-up tabulated as under:

Whereas, the rule 51 of J&K Public Service Commission (Business and Procedure ) Rules , 1980 as amended from time to time, further provides for the short listing of the eligible candidates to be called for interview in the ratio of 1:3 and as such total 87 candidates under OM Category , 27 candidates under RBA Category, 15 candidates under ST Category, 12 candidates under SC Category, 03 candidates under SLC Category and 03 candidates under ALC Category, against 29, 09,05,04,01 and 01 advertised posts respectively are to be shortlisted on the basis of the Academic Performance, Outreach and extra-curricular activities, Special attributes and Teaching skills as per the weightage detailed above; and

Whereas, after compilation of the data with respect to the above weightage points and the ratio to be adopted for short listing of candidates for interview, **the cut of merit under SC categories in respect of Assistant Professor, Dogri is 26.64. However the shortlisting of the candidates in OM, RBA, ST, ALC & SLC was not required as lesser number of candidates as required for shortlisting as per Rules had applied for the posts. Besides it, the candidature of candidates who do not possess the requisite eligibility NET/SET Or Ph.D has been cancelled. Also, the case of one Mr. Jatinder Singh applied for relaxation in the upper age was also placed before the Appellate Authority and was rejected by the appellate Authority ; and**


