Show Cause Notice

Whereas, the Written Examinations for Range Officer Grade-I (Forest) was held w.e.f 23-03-2019 to 27-04-2019 both at Srinagar as well as Jammu Centres; and

Whereas, the optional paper of Silviculture/Botany/Field Crop which was being conducted on 27-03-2019 and the Supervisor, J&K PSC Examination Hall Solina Srinagar had reported that you along with other four candidates (identified by the Supervisory Staff and through video recording) lead the unruly mob of candidates and started raising slogans in front of J&K PSC gate and tried to prevent the entry of the other candidates into the Examination Hall; and

Whereas, despite these threats and intimidation, the other candidates managed their entry into the Examination Halls and the Supervisor concerned, started the examination process as per the schedule by distributing the Question-Cum Answer Booklets among the present candidates; and

Whereas you along with other four identified candidates who were also outside the Examination Halls tried to break open the entry doors, so as to prevent other candidates from appearing in the Examination. However, you along with other four identified candidates were prevented from doing so by the Supervisory Staff and were advised to appear in the said examination peacefully. But you along with other four identified candidates were hell-bent upon disrupting the examination process and finally you succeeded in your nefarious design by breaking the glass of the entry gate of one of the Halls, followed by snatching and tearing off the distributed Question–Cum Answer Booklets of the other candidates who otherwise were writing their answer booklets peacefully; and



Whereas, you along with other four identified candidate also **misbehaved** with the Supervisory Staff deployed in the Examination Hall and damaged the glasses of the entry gate of the Commission; and

Whereas, a FIR has also been lodged in the Police Station Shergari regarding the above incident, and

Whereas, this **misbehavior** on your part is unbecoming of the candidate and you have jeopardized the future of other candidates who otherwise were peacefully present in the examination hall and had started attempting the question paper and had also marked their attendance.

In view of the above, you are hereby afforded an opportunity to present yourself before the Commission and to show cause as why you may not be debarred for appearing in any of the future examination conducted by J&K PSC, other PSC's of the other states and UPSC besides declaring you as "Failed" in all papers as punishment as envisaged in Rule 21 read with rule 25 of J&K PSC (conduct of Examination) Rules 2005, within 07 days from the date of issuance of this notice. Failing which the action proposed herein above shall be taken against you without any further notice.
