Sub: Rejection notice for the post of Assistant Professor Music (Instrument)/ Music (Vocal) in Higher Education Department.

Whereas, the Higher Education Department vide communication No. Edu/Coll/apptt./A.P/2014 had referred 08 (OM =04, RBA =02, & SC =02) posts of Assistant Professor Music (Instrument) to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/ suitable candidates in terms of SRO-124 dated 21.04.2014; and

whereas, the J&K Public Service Commission, vide Notification No. 12-PSC(DR-P) of 2014 dated 29.05.2014 invited applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification. In the said notification it was inter alia mentioned at Note-2 that the candidates who have already applied in response to Notification No.09-PSC(DR-P) of 2013 dated 23.05.2013 for the above mentioned post(s) need not apply subject to the fulfillment of eligibility requirement as laid down in SRO-124 dated 21.04.2014 ; and

whereas, in response to the above said Notifications, the Commission received 16 applications; and

whereas, after the scrutiny of the documents submitted by the candidates, it has been observed that some candidates are possessing Master's Degree in the stream of Music only; and

whereas, as per Recruitment Rules/Notification only such candidates are eligible for the post who are possessing Master's Degree in Music( Vocal) or Music Instrument.

Now therefore, in view of the above, the following candidates are intimated to furnish their proof of having their degrees in Music(Vocal) or Music Instrument from the concerned Competent Authority within ten days from the date of issuance of notice, other their candidature shall be rejected without further notice:-
