Whereas the Department of Law Justice and Parliamentary Affairs, J&K Civil Secretariat vide their letter No. LD(A)2011/70 dated 16.12.2013 referred 12 temporary vacancies of Civil Judge (Junior Division)/Munsiffs in the Subordinate Judiciary for being filled up through Competitive Examination in accordance with the rules laid down vide SRO 5 dated 4.1.1968 as amended from time to time:

Whereas the J&K Public Service Commission vide Notification No. PSC/Exam/2013/111 dated 24.12.2013 invited applications from the eligible candidates;

Whereas, in response to the above said notification, the Commission received 2029 applications for the said posts.

Whereas, the Commission considered the matter in its Extra-ordinary meeting held on 12.3.2014 and because of the large number of applications/candidates, the Commission was of the view that it will be desirable to conduct preliminary objective type test for short listing of the candidates for the written examination in a reasonable proportion to the number of posts advertised;

Now, therefore, all the eligible candidates who have applied for appearing in the **J&K Civil Service (Judicial) Competitive Examination, 2013 (Civil Judge (Junior Division)/Munsiffs)** in response to this Office Notification No. PSC/Exam/2013/111 dated 24.12.2013 are informed that the Preliminary Objective Type Test for short listing of candidates for Main Examination shall be conducted on 19.10.2014 in accordance with the syllabus already notified for compulsory papers vide above notification and as is also available on the website of J&K Public Service Commission www.jkpsc.nic.in.

The Admit cards will be issued in due course of time. However, those candidates who do not receive the Admit Cards upto 15.10.2014 may download the same from the Commission's website i.e. www.jkpsc.nic after 15.10.2014.

Note:

- 1. Only those candidates should appear in the Screening test, who fulfill the eligibility prescribed for the post as mentioned in the above Notification. However, permission to appear in the test is purely provisional subject to further verification of their documents at any stage of selection process.
- 2. The Name and Examination centre wise Notice shall be notified separately.
- 3. The candidature of such candidates shall be rejected at any stage of process of selection, as are found to have misrepresented or concealed the material facts having a bearing in his/her eligibility.
