Subject:- Filling up of the posts of Lecturer-I Architecture in Technical Education Department.

Important Notice
Dated: - 10 -07-2012.

Whereas, vide this office Notification No. 28-PSC (DR-P) of 2012 dated 25.04.2012, 02 (two) posts of Lecturer-I Architecture under Open Merit Category in Technical Education Department were notified; and

Whereas, vide this office Notice dated 31.05.2012 some candidates, who were shortlisted in pursuance of Rule 40 of J&K PSC (Business & Procedure Rules) 1980 amended from time to time were advised to submit their deficient documents; and

Whereas, a number of representations poured in from different quarters claiming that some shortlisted candidates, are not eligible for the posts of Lecturer-I Architecture in Polytechnic College, for their Degrees are not recognized by the Council of Architecture, New Delhi; and

Whereas, vide this office letter dated 21.06.2012, the matter was taken with Council of Architecture, New Delhi which intimated as under:-

“Only persons registered with Council of Architecture as architects and holding recognized qualifications under the Architects Act, 1972 may be considered for appointment to various architectural posts in your Commission.”

Now, therefore the following shortlisted candidates are advised to submit **proof of having obtained their Bachelors Degree in Architecture from the Institutes recognized by the Council of Architecture, New Delhi**

in the J&K Public Service Commission, Polo ground, Srinagar within 07(Seven) days from the date of issuance of the Notice, failing which candidature of such candidates shall be rejected without any further Notice in this regard.
