Whereas, the Higher Education Department, vide communication No. Edu/Coll/apptt./A.P/2014, dated 19.05.2014, among other posts had referred 50(OM=27,RBA=12,SC=04,ST=05, & ALC=02 ) posts of Assistant Professors in the discipline of Economics to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates in terms of SRO-124 dated 21.04.2014; and

Whereas, the J&K Public Service Commission, vide Notification No. 12-PSC(DR-P) of 2014 dated 29.05.2014, invited applications on prescribed format from the permanent residents of Jammu and Kashmir possessing the prescribed qualification. In the said notification, it was, inter alia, mentioned at Note-2 that the candidates who have already applied in response to Notification No. 09-PSC(DR-P) of 2013 dated 23.05.2013, for the above mentioned post(s) need not to apply subject to the fulfilment of eligibility requirement as laid down in SRO-124 dated 21.04.2014; and

Whereas, in pursuance of the commission decision taken in its extra ordinary meeting held on 06.01.2016 all such candidates, who have been declared to have qualified their SET/NET, by virtue of revised notifications were informed through the medium of the notice dated 07.01.2016, to submit their application along with the documentary proof of having qualified SET/NET in 2013 together with other documents to participate in interview process in their respective subjects as and when the interview schedule in their cases is notified provided they were otherwise eligible on the cutoff date i.e 02.07.2014; and

Whereas, in pursuance of the said Notice dated 07.01.2016, among other candidates, Mr. Basharat Hussain Bhat S/O Abdul Gani Bhat R/O Kanalwan, Anantnag, had also submitted a representation alongwith other documents for the posts of Assistant Professor Economics , ; and

Whereas after scrutiny of his documents, he was found provisionally eligible and was short-listed and called for interview for the post of Assistant Professor Economics, in Higher Education Department; and

Whereas, Mr. Basharat Hussain Bhat, S/O Abdul Gani Bhat R/O Kanalwan, Anantnag had also appeared in the interview for the post of Assistant Professor, Economics in Higher Education Department; and

Whereas while issuing a result and selection list of candidates, for the post of Assistant Professor, Economics in Higher Education Department, his result, figuring at S.No:06 in General Merit list, was kept withheld; and

Whereas Mr. Basharat Hussain Bhat S/O Abdul Gani Bhat R/O Kanalwan, Anantnag filed a writ petition No: 1010/2017 titled Basharat Hussain Bhat before the Hon'ble High Court at Srinagar; and

Whereas, the said writ petition was decided by the Hon'ble High Court, vide judgement dated 15/07/2017; and

Whereas, in pursuance of the said judgement of the Hon'ble High Court, the commission in its 13<sup>th</sup> extra ordinary meeting held on 21.08.2017, decided to implement the judgement.

Now, therefore, on the basis of performance of Mr. Basharat Hussain Bhat, S/O Abdul Gani Bhat R/O Kanalwan, Anantnag, in the interview coupled with the weightage in respect of academic merit, experience and other related parameters, he has secured 62.98 points under Open Category for the posts of Assistant Professor Economics in Higher Education Department.
