**Subject:** Short-listing/rejection of the candidates for the post of Assistant Professor, Political Science in Higher Education Department-submission of deficient documents thereof.

Whereas, the Higher Education Department vide communication No. Edu/Coll/apptt./A.P/2014 dated 19.05.2014, had referred 90(OM=49,RBA=17,SC=08,ST=10,ALC=04 and SLC=02) posts of Assistant Professors in the discipline of Political Science to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates in terms of SRO-124 dated 21.04.2014; and

Whereas, the J&K Public Service Commission vide Notification No. 12-PSC(DR-P) of 2014 dated 29.05.2014 invited applications on prescribed format from the permanent residents of Jammu and Kashmir possessing the prescribed qualification. In the said notification it was inter alia mentioned at Note-2 that the candidates who have already applied in response to Notification No. 09-PSC(DR-P) of 2013 dated 23.05.2013 for the above mentioned post(s) need not apply subject to the fulfilment of eligibility requirement as laid down in SRO-124 dated 21.04.2014

Whereas, the Commission vide its Notice dated 19.05.2016, issued short-listing/deficiency/rejection of the candidates for the post of Assistant Professor, Political Science in Higher Education Department; and

Whereas, among other candidates, Mr. Parvez Hassan Khan, Sr. No. 59 was also short-listed for the post of Assistant Professor, Political Science in Higher Education Department; and

Whereas, after afresh scrutiny of documents, of the short-listed candidates, it has been found that Mr. Parvez Ahmad Khan is over-aged by one month and twenty two days; and

Whereas, as per the eligibility criteria, the candidate is not eligible for the post of Assistant Professor, Political Science in Higher Education Department being overaged and in his place next candidate is required to be short-listed under Open Merit category; and

Whereas, as per the merit the next candidate namely Mr Pankaj Changotra possessing 54 points is falling next in merit under Open merit category in the short-listing criteria; and

Now, therefore, the candidature of Mr Parvez Hassan Khan is hereby rejected for the post of Assistant Professor(Political Science) in Higher Education Department and Shri Pankaj Changotra who is next in order of merit is hereby short-listed for the post of Assistant Professor(Political Science) in Higher Education Department. The revised cut off merit under Open Merit category is 54.00 instead of 54.06.
