The cutoff merit against each category is given as under:-

In respect of RBA against two posts eleven (11) candidates have been shortlisted and in case of ST category against one post (12) candidates have been shortlisted in pursuance of proviso to Rule 40(ii)(b) of the Jammu and Kashmir Public Service Commission Business & Procedure Rules, 1980. However, there is no candidate between the merit of last shortlisted candidate under open merit category and the merit of last candidate shortlisted under RBA category.

Further, the candidature of Shri Imtiyaz Assad, Bar Code No. 139967 has been rejected under RBA category who has been found Ineligible in terms of the Recruitment Rules/Regulations of 2009

The candidates who do not figure in the short-list may approach before the Commission within three days positively with documents in support of their claim of having higher merit (if any), than the cut off merit.
