Subject: Interview for the post of Assistant Professor, Kashmiri in Higher Education Department.

Notice

Dated: 27.02.2016

Whereas, the Higher Education Department vide communication No. Edu/Coll/apptt./A.P/2014 dated 19.05.2014, had referred 12 posts (OM=6, RBA=3, ST=1, SC=1, ALC=1) of Assistant Professor in the discipline of Kashmiri to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates in terms of SRO-124 dated 21.04.2014; and

whereas, the J&K Public Service Commission, vide Notification No. 12-PSC(DR-P) of 2014 dated 29.05.2014 invited applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification. In the said notification it was inter alia mentioned at Note-2 that the candidates who have already applied in response to Notification No. 09-PSC(DR-P) of 2013 dated 23.05.2013 for the above mentioned post(s) need not apply subject to the fulfillment of eligibility requirement as laid down in SRO-124 dated 21.04.2014, and

whereas, in response to the above said Notifications, the Commission received 61 applications; and

whereas, these applications were scrutinized and Deficiency /Rejection notice was issued vide Notice Dated:- 11-12-2015; and

whereas, vide Notice dated:- 11-12-2015 the candidature of one candidate namely Mohammad Hussain Parray was rejected among other candidates on the grounds of being over aged by 14 years; and

whereas, aggrieved by the rejection notice, he approached the Hon'ble High Court through SWP No:- 301/2016, MP No:01/2016 with the prayer that he may be given the age relaxation; and

whereas, the Hon'ble High Court vide its Order Dated:- 24-02-2016 issued directions, the operative part of which is reproduced as under;

“ In the mean time, subject to objections from other side and till next date before the Bench, petitioner be interviewed for the post of Assistant Professor in the discipline of Kashmiri advertised pursuant to notification No:- PSC/DR/Astt. Prof/Kashmiri Dated:- 20-02-2016. The result of the petitioner , however, shall not be declared till further orders.” and

whereas , the Commission has fixed the interview schedule for the post of Assistant Professor in the Discipline of Kashmiri from 29-02-2016 to 01-03-2016 vide notice dated:- 20-02-2016.

Now, therefore, in view of the above and in compliance with the Hon'ble High Court directions dated 24-02-2016, the petitioner named above is hereby informed through the medium of this Notice to appear in the interview on 01-03-2016 at 09 A.M at his own risk and responsibility at J&K Public Service Commission office at Resham garh Colony, Jammu. This is without prejudice to the stance of the J&K Public Service Commission as may be taken/adopted in the SWP based on the principle of eligibility.
