Sub:-Recommendation of Selection for the Post of Lecturer, (10+2) Chemistry in School Education Department.

Notification No:- 32-PSC (DR-S) of 2017

Whereas, the result of selection for the post of Lecturer, (10+2) Chemistry in School Education Department was declared vide Notification No:-18-PSC (DR-S), Dated:-17-04-2017, and

Whereas, after issuance of the above Notification, a representation was received by the Commission from one Ms. Iqra Akhtar D/o Ghulam Hassan figuring at S.No:- 7 in the waiting list under Open Merit Category with regard to non-accounting of 01 mark for Gold Medal/1st Rank in the Marks Awards, and

Whereas, the representation was thoroughly examined and the Commission arrived at the following conclusions:-

“The representation of Ms. Iqra Akhtar was found based on facts and it has been observed that she has inadvertently not been awarded 01 mark for Gold Medal/1st Rank and after awarding 01 point for the said attributes her total score comes to 62.17 instead of 61.17. Keeping in view her new merit, she is to be included in the select list at S.No:- 51 under open merit category. By including her candidature, the candidate selected at S.No:-58 namely Mehraj Ud Din Bhat who belongs to RBA Category will be dislodged from the open merit category and shall figure at S.No:-1 of the select list under RBA Category. The candidate figuring at S.No:-20 of the RBA Category namely Mehraj Ahmad Bhat shall now figure at S.No:-1 of the waiting list under RBA Category. Sh Tanveer Ahmad Bhat figuring at S.No:-4 of the waiting list shall be deemed to have been excluded from the waiting list.”

Whereas, the above inclusions and exclusions shall be effected in the respective select lists as shown in the table given below:-
