ORDER NO. 02 - PSC OF 2014

Whereas, vide Public Service Commission's Notification No. 16-PSC(DR-P) of 2013 dated 17.08.2013, applications were invited from the permanent residents of Jammu and Kashmir State possessing the prescribed qualification and age for the post of Medical Officers in the Health & Medical Education Department;

Whereas, among others the following candidate had also applied for the said post under RBA Category and had not furnished the requisite document:-

Whereas, the candidate had furnished her photostate copy of RBA Category Certificate issued by the Tehsildar Anantnag vide No. 609/BAC dated. 14.8.2008 and its validity was upto 13-09-2013. The cut of date of submitting of application forms was fixed as on 19-09-2013;

Whereas, the candidate who was provisionally called for interview produced the original documents on the date of interview i.e. 06-01-2014 before the interview board and after examining of the original RBA certificate issued by the Tehsildar Anantnag revealed that the validity of the certificate had expired on 19.09.2013 and also the entries are overwritten;

Whereas the candidate has completed her internship on 17-12-2001 as per the certificate issued by the Competent Authority vide No, SS/1390-91/MC dated. 22-02-2002 and also produced a certificate from Directorate of Health Services Kashmir issued vide letter No. ES-3/1-133/3232 dated. 19-01-2006 which reveals that the candidate has worked as Assistant Surgeon in the Health & Family Welfare Department in Block Larnoo w.e.f. 5-10-2000 to 25-06-2006 in the capacity of Adhoc whereas the candidate has completed her internship on 17-12-2001;

Whereas, the Date of Birth of the candidate is 01-12-1973 and is overaged in Open Merit Category, while as the candidate has applied for the post of Medical Officer in RBA category but failed to produce valid RBA certificate;

Whereas, the candidate has secured 55 points in the Screening Test while the cut off merit in the open category is 66 and does not qualify even under Open Merit Category;

Whereas, the candidate has again failed to produce the valid category certificate on the date of her interview.

In this background the candidate has not been found eligible for the said post neither in Open category nor in RBA Category. Hence her candidature is hereby rejected.
