Whereas, the Health and Medical Education Department, vide communications bearing Nos.HME/HRM/54/2013 and DH/Gaz/129/2018-I dated:27-09-2018, referred One Thousand (1000) posts of Medical Officer (Allopathic), under different categories, to the Commission for being filled up in accordance with the J&K Health and Family Welfare (Gazetted) Service Recruitment Rules, 2013 as amended vide SRO 388 dated:10-09-2018 read with SRO 202 dated:30-06-2015; and

Whereas, online applications were, accordingly, invited from the candidates, possessing the requisite eligibility, vide Notification No.12-PSC(DR-P) of 2018 dated:15-10-2018. In response, 2969 applications were received, out of which 2694 candidates appeared in the Written Test, held on 02-12-2019, and the result was declared, vide Notification No.PSC/Exam/81/2018 dated:8-12-2018; and

Whereas, consequent upon the above and vide Notice dated: 10-12-2018, the qualified candidates were advised to report to the designated Nodal Officers, as per the schedule inter-alia mentioned in the notice ibid, for purposes of verification of their documents; and

Whereas, upon such verification, the candidates fulfilling the laid down criteria and possessing requisite eligibility were recommended to the Government for their appointment, vide Notification No.PSC/Exam/84/2018 dated:20-12-2018; and

Whereas, with a view to meeting the ends of justice and before rejecting their candidature, Notice dated: 29-12-2018 was issued and candidates who had either chosen not to be present for verification of the documents or were found not to be fulfilling the eligibility conditions were given last opportunity to substantiate/present their claims, within 07 days i.e by or before 6th of Jan. 2019, in the Commission office at Resham Ghar Colony, Bakshi Nagar, Jammu/Camp Office Solina Srinagar; and



Whereas, upon verification of the documents furnished by the candidates, the following 09 candidates have been found not to be in possession of the Registration Certificate(s), issued by the State Medical Council, before the cutoff date i.e.15-11-2018, in view of which their candidature is liable to rejection; moreso keeping in view the forewarning given through Notice dated 17-10-2018 in terms of which all the candidates were warned about the implications of the entering wrong data/misleading information especially with regard to Qualification, Internship and Registration and that in such cases the candidature of the candidates shall be rejected notwithstanding qualifying the written test;
