
- i. For checking the result, candidates are advised to access the official website of the Commission i.e. <http://www.jkpsc.nic.in>.

- iii. Only eligible candidates, possessing requisite qualification prescribed under rules, shall be allowed to appear in the Oral Test/Viva-Voce subject to the condition that they are within the prescribed age limit on the cut-off date.
- iv. The candidates, who qualified the Written Test, are advised to submit hard copy of their online application form along with the fee receipt at J&K PSC office, Solina, Srinagar/Resham Ghar Colony, Bakshi Nagar, Jammu or send the same to the address of the Controller of Examinations, J&K Public Service Commission, Solina Rambagh, Srinagar/Resham Ghar colony, Jammu by registered post. Only such

identified documents as have been posted and delivered in the Commission Office by or before the cutoff date shall be considered.

v. Candidates possessing Degrees obtained through Distance Mode shall be allowed to appear before the Interview Board subject to their satisfying the conditionality's prescribed under Government Order No. 252-HE of 2012 dated: 30.05.2012 & production of the documentary evidence in this regard.

vi. The candidates shall produce their original certificates/testimonials on the date of oral test/Viva-Voce.


