In pursuance of Rule 32 of J&K Public Service Commission (Conduct of Examinations) Rules, 2005 read with Rule 40 of J&K Public Service Commission (Business & Procedure) Rules, 1980, the candidates as per Annexure-A to this notification are hereby declared to have qualified for the Oral Test for the posts of Lecturer 10+2 Dogri in School Education Department on the basis of their performance in the Written Test which was held on 04.02.2018.

Note:

- i. The candidature of candidates shown in **Annexure-A** is purely provisional;
- ii. Only eligible candidates possessing requisite qualification prescribed under rules shall be allowed to appear in the Oral Test/Interview subject to the condition that they are within the prescribed age limit on the cut off date.
- iii. Candidates possessing Degrees through distance mode shall have to produce a proof of having degree within the purview of Government Order No. 252-HE of 2012 dated: 30.05.2012 from Competent Authority of the concerned University.
- iv. The candidates shall produce their original certificates/testimonials, original fee receipt and one complete set of self-attested photocopies of all the documents on the date of oral test/Interview.
- v. Oral Test/Interview of the eligible candidates shall be held tentatively w.e.f **22.03.2018**. However, the detailed schedule for Oral Test/interview will be notified separately.

This is subject to the outcome of writ petitions, if any, pending disposal before the Hon'ble High Court of J&K.
