The result of the Preliminary /Screening Test held for the posts of Range Officer (Soil Conservation) in Forest Department on 29.11.2015, is declared as per Annexure –A to this Notification.

The representations received after the conduct of preliminary/screening test have been disposed off after obtaining the opinion from the subject matter experts.

The Commission has adopted the Sub rule(2) of Rule 8 of J&K Combined Competitive Examination Rule, 2008 and the law laid down including the Judgment of Hon'ble Supreme Court in A.P. Public Service Commission Vs Balaji Badhavath & Ors (Civil Appeal No. 2244 of 2009) for the purpose of shortlisting the candidates for appearing in the main examination.

While adopting the above rule, the Commission has decided to call 1/3rd of the total no. of candidates who have appeared or 25 times the approximate no. of vacancies whichever is lower. Out of 107 enrolled candidates only 72 candidates appeared in the preliminary examination, thus 24 candidates in order of merit have been declared to have qualified for the main examination; thereby making the last cutoff point as **75.789** marks. Due to a tie amongst 5 candidates at the last cutoff point, 04 additional candidates get qualified for the main examination; thus taking the total number of qualified candidates to 28.

The candidature of the candidates who are declared to have qualified for main examination (essay type) is purely provisional and subject to determination of final eligibility.

This is subject to the outcome of any writ petition, pending disposal in the Court of competent jurisdiction on the subject.
