Subject: Revised shortlisting notice for the post of Assistant Professor (Bio-Chemistry) in Higher Education Department.

Whereas, the Higher Education Department vide communication No. Edu/Coll/apptt/A.P/2014 dated 19.05.2014, referred 09 (Nine) posts **OM=05, RBA=02 SC-01 and ST=01** of Assistant Professors in the discipline of Bio-Chemistry to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates in terms of SRO-124 dated 21.04.2014; and


Whereas, the J&K Public Service Commission, vide Notification No. 12-PSC(DR-P) of 2014 dated 29.05.2014 invited application on prescribed format from the permanent residents of Jammu and Kashmir possessing the prescribed qualification. In the said notification it was inter alia mentioned at Note-2 that the candidates who have already applied in response to Notification No. 09-PSC(DR-P) of 2013 dated 23.05.2013 for the above mentioned post(s) need not apply subject to the fulfilment of the eligibility requirement as laid down in SRO-124 dated 21.04.2014; and

Whereas, vide notice dated 21.04.2016, shortlist/rejection/deficiency notice for the post of Assistant Professor(Bio-Chemistry) in Higher Education Department was issued; and

Whereas, after fresh scrutiny of the documents of the shortlisted candidates, it has been found that Saba Rasool and Yasrib Qureshi existing at Sr.No. 22 & 23 in the shortlisted notice under Open Merit category are possessing only 66.60 & 68.40 points respectively and were inadvertently shortlisted as the cut off merit under Open Merit category was fixed as **71.44**.

Now therefore, as per the shortlisting criteria these two candidates namely Saba Rasool and Yasrib Qureshi existing at Sr.No. 22 & 23 in the shortlisted notice under Open Merit category are excluded from the short-listing notice and in their place two candidates namely Shri Hilal Ahmad Wani S/o Shri Ghulam Mohi-ud-Din and Nishawar Jan D/o Shri Ghulam Mohi-Ud-Din who are possessing 71.55 & 71.48 respectively are hereby shortlisted for the post of Assistant Professor (Bio-Chemistry).

The other terms and conditions as notified vide notice dated 21.04.2016 shall remain same.
