Subject: Rejection of Application Forms for appearing in Combined Competitive (Main) Examination, 2012.

Whereas, the J&K Public Service Commission vide Notification dated 31.08.2012 invited Application Forms in terms of Rule 8 of SRO 387 dated 01.12.2008 read with SRO 168 of 2011 dated 31.05.2011 from successful/eligible candidates for appearing in Combined Competitive (Main) Examination, 2012; and

Whereas, in response to above said Notification J&K Public Service Commission received 1606 Application Forms from successful candidates; and

Whereas, the eligible candidates were required to attach requisite documents with their Application Forms as provided in Rule 7 of SRO 387 dated 01.12.2008; and

Whereas, the Application Forms alongwith attached documents were scrutinized in the office and on scrutiny some Application Forms were found deficient on various grounds; and

Whereas, vide PSC notice dated 24.11.2012 the concerned candidates (i.e. 30 in Group 'A' and 13 in Group 'B' of PSC Notice) in terms of Rule 30 of J&K Public Service Commission (Business & Procedure) Rules, 1980 were asked to submit their deficient documents by or before 05.12.2012; and

Whereas, out of 43 candidates only 24 candidates have made up their deficiencies making them eligible to appear in the Combined Competitive (Main) Examination, 2012; and

Whereas, out of 43 candidates, 19 candidates i.e. (9 from Group 'A' and 10 from Group 'B') failed to submit the requisite documents proving their eligibility within stipulated period; and

Now, therefore, it is notified for information of the concerned that: -

- (a) In absence of In-service certificates Roll No.1700747, 1701370, 1701371 & 0900935 cannot be treated as In-service candidates. However, they are eligible to appear in the Main Examination.
- (b) In absence of RBA certificate Roll No.2001758 is treated in O.M category instead of RBA category.
- (c) In the absence of requisite Character certificate the Application Forms of Roll No. 1700506, 0200289, 2000431 & 0900428 are rejected ab-initio.
- (d) The Application Forms of Roll No. 1600017, 1701795, 2001628, 1901276, 1901192, 2001112, 2001195, 1200815, 2202397 and 2001950 are rejected as being ineligible to appear in the Combined Competitive (Main) Examination, 2012 as they have not produced proof of having fully appeared in the Graduate Degree Examination on or before the cutoff date i.e. 15.05.2012/have not produced proof of passing such degree examination. However, in accordance with Rule 31 of J&K Public Service Commission (business and Procedure) rule, 1980, amended upto 2011; any candidate who is aggrieved of the rejection order may appeal to the Commission, with supporting documents within a period of 10 days (on or before 22.12.2012).
