Subject: Interview for the post of Assistant Professor, Kashmiri in Higher Education Department.

Whereas, the Higher Education Department vide communication No. Edu/Coll/apptt./A.P/2014 dated 19.05.2014, had referred 12 posts (OM=6, RBA=3, ST=1, SC=1, ALC=1) of Assistant Professor in the discipline of Kashmiri to the J&K Public Service Commission for being filled up through direct recruitment amongst the eligible/suitable candidates in terms of SRO-124 dated 21.04.2014; and

whereas, the J&K Public Service Commission, vide Notification No. 12-PSC(DR-P) of 2014 dated 29.05.2014 invited applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification. In the said notification it was inter alia mentioned at Note-2 that the candidates who have already applied in response to Notification No. 09-PSC(DR-P) of 2013 dated 23.05.2013 for the above mentioned post(s) need not apply subject to the fulfillment of eligibility requirement as laid down in SRO-124 dated 21.04.2014, and

whereas, in response to the above said Notifications, the Commission received 61 applications; and

whereas, these applications were scrutinized and it was observed that none of the candidates applied in ST, SC and ALC categories ; and

whereas, Sh. Riyaz Ahmad Naik , Sh. Shaista Ahmad and Sh. Shoukat Ahmad approached the Hon'ble High Court Srinagar through a SWP:-87/2016, MP No:-01-2016 with the prayer to consider them against the Posts reserved for ST, SC and ALC categories; and

whereas the Hon'ble High Court vide its order Dated:-22-01-2016 issued directions, the operative part of which is reproduced as under:

**“ In the mean time, Public Service Commission shall conduct the interview of the petitioners against the posts of Assistant Professors under SC, ST and ALC in their respective disciplines on their own risk and responsibility, however, their results shall not be declared till further orders.”**

Whereas , the Commission has fixed the interview schedule for the post of Assistant Professor in the Discipline of Kashmiri from 29-02-2016 to 01-03-2016 vide notice dated:- 20-02-2016.

Now, therefore, in view of the above and in compliance with the Hon'ble High Court directions dated 22-01-2016, the petitioners named above are hereby informed through the medium of this Notice to appear in the interview on 01-03-2016 at 09 A.M at their own risk and responsibility at J&K Public Service Commission office at Resham garh Colony, Jammu. This is without prejudice to the stance of the J&K Public Service Commission as may be taken/adopted in the SWP based on the principle of eligibility.
