Whereas, the Power Development Department referred 44 posts (OM:25, RBA:09, SC:03, ST:04, ALC:02 & SLC:01) of Assistant Engineer (Electrical) to the Public Service Commission for being filled up from amongst the suitable candidates; and

whereas, the Commission notified these posts vide Notification No. 15-PSC (DR-P) of 2013 dated 12.08.2013; and

whereas, in response to the above notification, **2814** applications were received; and

whereas, a Computer Based Screening test was conducted on 30.11.2017 at two notified centres viz. Jammu & Srinagar in which 1360 candidates appeared. The result of the Computer Based Recruitment test was declared on 22.12.2017 vide Notification No. PSC/Exam/2017/84 in pursuance of Rule 32(a) of J&K Public Service Commission (Conduct of Examinations) Rules, 2005 and rule 40 of the Jammu and Kashmir Public Service Commission (Business & Procedure) Rules, 1980 and accordingly 136 applicants (candidates) were declared to have qualified in the ratio of 1:3 after application of tie rule and called for Oral test/interview; and

whereas, the interview of the shortlisted candidates was conducted w.e.f. 02.01.2018 to 04.01.2018 with the assistance of experts from outside the state.

whereas, 01 more candidate was allowed to participate in the interview on the directions of the Hon'ble High Court in SWP No. 3105/2017, M.P. No.1/2017 titled Irfa Amin Vs State of J&K & others. The operative part of the directions are reproduced as under:-

"Keeping in view the position as noticed herein above the interim protection has to be granted, therefore, respondents 2 to 4 are directed to admit the petitioner to interview which shall be solely at her own risk and responsibility. Result of the petitioner, however, shall not be declared until further orders from this Court."

whereas, Hon'ble High Court in SWP No.2379/2015 titled Sachin Tickoo & Others V/S State and Others in its judgement dated 25.08.2015 has directed to issue the select list of candidates who have appeared before the interview board in the stream of Assistant Engineer (Electrical) in Power Development Department. The Hon'ble Court judgement is reproduced below:-

"Meanwhile, subject to objections from other side, notice dated 20.08.2015 shall remain stayed not only in regard to the petitioners but also in regard to the other candidates, whose candidature has been rejected alongwith the petitioners on the ground of possessing B.E. (Electronics), who had applied for the post of Assistant Engineer (Electrical) pursuant to notification dated 12.08.2013. They will also be considered for appointment as Assistant Engineer (Electric). It is further made clear that result of the petitioners as also other similarly situated persons possessing B.E (Electronics) shall not be declared and no final orders of appointment shall be issued till objections are filed and considered by this court."

whereas, the Hon'ble High Court vide its order dated 15.03.2018, reserved one post for the petitioner in Assistant Engineer (Electric) in SWP No.2518/2015 titled Siddarth Wazir & Others V/S State of J&K & Others. The relevant extract of the order is reproduced as under: -

"The direction dated 28.12.2017 is modified by providing that finalization of the selection process shall remain subject to the outcome of the MP. Further, in order to protect the interest of the petitioner No.2, one post shall not be filled up till further orders from this court."

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates having basic stream B.Tech. in Electrical Engineering who have appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

#### Note:-

1. The Commission reserves the right to have certificates/documents of the candidates verified, if it is at any stage found expedient to do so. The Select List is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
