Subject: Select List for the posts of Assistant Professor (Botany) in Higher Education Department.

Notification No. 54 – PSC (DR-S) of 2019
Dated: 15.07.2019

Whereas, the Higher Education Department referred 10 posts [OM:06, RBA:02, SC:01 & ST:01] of Assistant Professor (Botany) to the Public Service Commission for being filled up from amongst the suitable candidates; and,

Whereas, the Commission notified these posts vide Notification No. 10-PSC (DR-P) of 2017 dated 27.10.2017; and,

Whereas, in response to the above notification, 466 applications were received. Out of these, 30 eligible candidates were shortlisted and called for interview; and,

Whereas, 02 more candidates were interviewed on the basis of Court directions in various writ petitions, the details of which are given below:-

SWP NO. 763/2019 & IA NO. 1/2019 Titled Dr Rameshwar Groach V/S State & J&K Public Service Commission.

“In the meantime the petitioner shall be allowed to appear in the interview for the post of Assistant Professor, Botany in Higher Education Department, Jammu advertised vide Advertisement Notice dated: 27.10.2017 on his own risk and responsibility. This, however, shall not confer any right of selection on the petitioner. His result shall not be declared till further orders from this Court.”

SWP NO. 1670/2019 & CM 3082/2019 Titled Darakhshanda Neelam V/S J&K Public Service Commission & Anr.

“In the meantime, Respondent, Public Service Commission, shall allow the petitioner to compete in the process of selection and interview her on the scheduled date i.e. 13th & 14th May, 2019, on her own risk and responsibility. The result of the petitioner shall not, however, be declared until further orders. It goes without saying that mere permission to participate in the selection process shall not create any enforceable right in favour of petitioner to seek the usufruct of such participation.”

Whereas, the interview of the shortlisted candidates was conducted on 15.05.2019 and 16.05.2019 with the assistance of experts.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

Note:-

1. The Commission reserves the right to have certificates/documents of the candidate verified, if it is at any stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
2. The select list is provisional. Any objection may be submitted to the Commission within five days for examination and disposal. No claim will be entertained after five days from the date of issuance of Notification.
