1. The Commission reserves the right to have certificate/documents of the candidate verified, if it is at any stage found expedient to do so. The Select List is provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
2. One post under SC category remained unfilled as only one candidate who participated in the interview could not qualify the minimum bench mark of 40% for selection under rule 51(v) of J&K PSC (Business & Procedure), 1980 as amended from time to time.
3. One post under RBA category remained unfilled due to non-availability of candidates.
