Whereas, the Health & Medical Education Department referred 10 posts in the discipline of Lady Medical Officer, two each in GMC [Anantnag, Baramulla, Kathua, Rajouri and Doda] to the Public Service Commission for being filled up from amongst the suitable candidates.

Whereas, the Commission notified these posts vide Notification No. 01-PSC(DR-P) of 2018 dated:17.01.2018; and

Whereas, in response to the above notification, **499** applications were received; and

Whereas, the written test of the candidates for selection was conducted on 30.09.2018 in which \_\_\_\_ candidates appeared. The result of the written test was declared vide Notification No. PSC/Exam/2018/70 dated: 05.10.2018 in pursuance of Rule 32(a) of the J&K Public Service Commission (Conduct of Examinations) Rules, 2005 and Rule 40 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and 35 candidates were declared to have qualified the written test and called for interview; and

Whereas, the interview of the shortlisted candidates was conducted w.e.f. 24.10.2018 to 26.10.2018 with the assistance of experts; and

Whereas, 01 post under Open merit in GMC-Anantnag and 02 posts each under Open Merit in GMC- Baramulla and Rajouri could not filled up as no candidate from the said category has achieved the bench mark of 52.25%.

Now, therefore, on the basis of the performance in the interview coupled with the weight-age accorded to the marks secured in written test in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available post is given in **Annexure-B** to this Notification.

Further, the marks obtained by the candidates who appeared in the written examination on 30.09.2018 are given in **Annexure-C** to this notification for information of the candidates.
