Whereas, the Health & Medical Education Department referred 02 posts, one each under Open Merit and RBA category of Lecturer Radio Diagnosis (GMC-Jammu) to the Public Service Commission for being filled up from amongst the suitable candidates; and

Whereas, the Commission notified these posts vide Notification No. 02-PSC(DR-P) of 2017 dated:01.05.2017; and

Whereas, in response to the above notification, 14 applications were received which were scrutinized and accordingly 13 eligible candidates were shortlisted for participation in the interview; and

Whereas, the interview of the eligible candidate was conducted on 10.12.2018 with the assistance of experts from outside the state; and

Whereas, a writ petition was filed in the Hon'ble High Court against the Notification No.02-PSC (DR-P) of 2017, the operative part of the direction of the Hon'ble High Court passed in IA No.02/2018 in LPA NO.65/2018 on 10.12.2018 is reproduced as under: -

***“... Meanwhile subject to objections from other side and till next date before the Bench, respondents shall not fill up the post of Lecturer Radio Diagnosis in Government medical College, Jammu which is lying vacant due to resignation of one Dr. Nitin Vermani.”***

Now, therefore, on the basis of performance in the interview and the weightage earned in respect of academic merit, qualifications, experience etc. and the overall performance, **Dr. Vikrant Gupta S/O S.C. Gupta R/O House No.40, lane No.1, Garden Avenue, Talab Tillo, Jammu** who has secured **53.02** points is recommended for selection against the available post under **RBA Category**.

**Note:-**

1. The Commission reserves the right to have certificates/documents of the candidate verified, if it is at any stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.

2. The select list is provisional. Any objection may be submitted to the Commission within five days for examination and disposal. No claim will be entertained after five days from the date of issuance of Notification.
