Whereas, the Health & Medical Education Department referred 01 post under Open Merit vide letter No. ME/Gaz-187/2014 dated 11.04.2017 for GMC Jammu, 02 posts [OM:01, RBA:01] vide letter No. ME/Gaz-187/2014-I dated 11.04.2017 for GMC, Jammu & 03 posts of Lecturer [OM:02 and SC:01] vide letter No. ME/Gaz-154/2012 dated 15.06.2017 for GMC, Srinagar in the discipline of Pathology for recommendation of selection of suitable candidates; and

Whereas, the J&K Public Service Commission advertised these posts vide Notification No. 02-PSC (DR-P) of 2017 dated 01.05.2017 and No.05-PSC (DR-P) of 2017 dated 10.07.2017.; and

Whereas, in all, 26 applications were received vide Notification No. 02-PSC (DR-P) OF 2017 dated 01.05.2017 for GMC, Srinagar, 21 applications vide Notification No.02-PSC (DR-P) of 2017 dated 01.05.2017 for GMC, Jammu and 32 applications vide 05-PSC (DR-P) OF 2017 dated 10.07.2017 for GMC, Srinagar. Out of these, 24 candidates and 21 candidates under first notification and 26 applicants under second notification were found eligible and called for interview; and

Whereas, the interviews of the candidates were conducted on 14.05.2018 & 15.05.2018 with the assistance of experts from outside the State; and

Whereas, one post under SC category against Notification No.05-PSC (DR-P) of 2017, GMC, Srinagar left vacant due to non-availability of candidate.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the list of the candidates who have appeared in the interview is enclosed as Annexure-“A” to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.
