Whereas, the Health & Medical Education Department referred 02 posts (OM-01 & ALC-01) of Lecturer in the discipline of Pathology (GMC Jammu) to the Public Service Commission for being filled up from amongst the suitable candidates; and

Whereas, the Commission notified these posts vide Notification No. 04-PSC(DR-P) of 2016 dated:24.02.2016; and

Whereas, in response to the above notification, **23** applications were received. Out of these, 20 applicants were found eligible and called for interview. Out of which, only 06 candidates appeared before the Interview Board; and

Whereas, the interviews of the candidates were conducted on 06.07.2017 with the assistance of experts from outside the State; and

Whereas, one post under ALC category left unfilled due to non-availability of candidate(s); and

Whereas, the select list could not be finalized due to Hon'ble High Court directions in SWP No.1277/2017 and M.P. No.1/2017 titled Dr. Archana Gupta and Another V/S State and Others; and

Whereas, the Commission met on 05.03.2018 to finalize the select list so that the same could be produced before the Hon'ble High Court on 06.03.2018; and

Whereas, the case was listed on 15.03.2018 and the Hon'ble High Court has allowed the Commission to make the selection.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the list of the candidates who have appeared in the interview is enclosed as Annexure-"A" to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

1. The Commission reserves the right to have certificates/documents of the candidates verified, if it is at any stage found expedient to do so. The Select List is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
