Whereas, the Health & Medical Education Department referred 39 posts (OM:22, RBA:08, SC:04, ST:04 & ALC:01) of Medical Officer Unani to the Public Service Commission for being filled up from amongst the suitable candidates; and

Whereas, the Commission notified these posts vide Notification No. 04-PSC (DR-P) of 2018 dated 13.03.2018; and

Whereas, in response to the above notification, **612** applications were received; and

Whereas, the written test of the candidates for selection was conducted on 30.09.2018 in which **529** candidates appeared. The result of the written test was declared vide Notification No. PSC/Exam/2018/69 dated: 05.10.2018 in pursuance of Rule 32(a) of the J&K Public Service Commission (Conduct of Examinations) Rules, 2005 and Rule 40 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and **120** candidates were declared to have qualified the written test and called for interview; and

Whereas, 01 more candidate was allowed to participate in the interview on the directions of the Hon'ble High Court in SWP No.2462/2018 titled Munawar Iqbal v/s State of J&K & others. The operative parts of the directions are reproduced as under:-

"... Meanwhile, subject to objections and till next date before the Bench, petitioner shall be permitted to sit in the interview for the post of Medical Officer Unani on his own risk and responsibility. Mere appearance in the interview will not create any indefeasible right in favour of the petitioner to claim any benefit on that basis. The result of the petitioner shall not be declared unless directed."

Whereas, the interviews of the shortlisted candidates were conducted w.e.f. 04.12.2018 to 06.12.2018 with the assistance of experts from outside the state.

Whereas, 04 posts under ST category and 01 post under ALC category could not filled up as no candidate from the said category achieve the bench mark of 45%. Further 04 posts under SC category left vacant due to non-availability of candidates.

Now, therefore, on the basis of the performance in the interview coupled with the weight-age accorded to the marks secured in written test in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the Merit of the candidates who have appeared in the interview is enclosed as Annexure-"A" to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

Further, the marks obtained by the candidates who appeared in the written examination on 30.09.2018 are given in **Annexure-C** to this notification for information of the candidates.

- 1. The Commission reserves the right to have certificates/documents of the candidates verified, if it is at any stage found expedient to do so. The Select List is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
