Whereas, the School Education Department referred 02 posts (RBA:01 & ST:01) of Lecturer in the discipline of Music to the Public Service Commission for being filled up from amongst the suitable candidates; and

Whereas, the Commission notified these posts vide Notification No. 09-PSC (DR-P) of 2016 dated 19.03.2016; and

Whereas, in response to the above notification, **15** applications were received; and

Whereas, the written test of the candidates for selection was conducted on 30.09.2018 in which **04** candidates appeared. The result of the written test was declared vide Notification No. PSC/Exam/2018/18 dated: 17.11.2018 in pursuance of Rule 32(a) of the J&K Public Service Commission (Conduct of Examinations) Rules, 2005 and Rule 40 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and **03** candidates were declared to have qualified the written test and called for interview; and

Whereas, the interviews of the shortlisted candidates was conducted on 03.12.2018 with the assistance of experts from outside the State.

Now, therefore, on the basis of the performance in the interview coupled with the weight-age accorded to the marks secured in written test in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the Merit of the candidates who have appeared in the interview is enclosed as Annexure-“A” to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

Further, the marks obtained by the candidates who appeared in the written examination on 30.09.2018 are given in **Annexure-C** to this notification for information of the candidates.
